### Application Rate | Optimized for Hydroponic Use

**Hydroponic/Soilless** 8 - 15 oz./100 gal. 2.4 - 4.61 ml./gal.

**Soil/Outdoor Use:** 4 - 7 lbs. in a minimum of 100 gal. of water applied per Acre every 7 - 14 days. 0.5 - 1.5 oz. in minimum of 2.5 gal. of water applied per 1000 sq. ft. every 7 - 14 days.

**Recommended Hemp Use:** 30 lbs./Acre every week for 16 weeks
